ARTISTIC SERVICES: DURING OUR 16TH SEASON (2023-2024), WE PRODUCED FOUR PLAYS THAT DREW 11,155 AUDIENCE MEMBERS, INCLUDING 2,232 FIRST TIME TICKET BUYERS. THE SEASON OPENED IN OCTOBER 2023 WITH "ROALD DAHL'S MATILDA: THE MUSICAL." OUR PRODUCTION OF MATILDA WAS A BOX OFFICE HIT, AND WE SUCCESSFULLY WE REMOUNTED THE SHOW IN JUNE 2024. OUR ANNUAL HOLIDAY SHOW (INSPIRED BY DICKENS' "A CHRISTMAS CAROL") SOLD 4,263 TICKETS OVER FIVE WEEKS. IN SPRING 2024 WE PRODUCE THE AUTOBIOGRAPHICAL ROCK MUSICAL "PASSING STRANGE," WHICH CHRONICLES A BLACK MAN'S ARTISTIC JOURNEY OF SELF DISCOVER FROM MIDDLE CLASS LOS ANGELES TO A PUNK COLLECTIVE IN 1980S BERLIN. AUDIENCE FEEDBACK FROM "PASSING STRANGE" INCLUDED THAT "IT WAS A ROLLERCOASTER RIDE OF THE SENSES" AND THAT "I FELT MY OWN STORY COME ALIVE FROM WATCHING THIS PRODUCTION."
